

Welcome to the Directory of the New York State Prisoner Justice Network!

The Directory represents the member organizations of the New York State Prisoner Justice Network.

The Network grew from the first-ever New York State Prisoner Justice Conference, held in Albany on March 27th, 2010. The Conference had nearly 200 attendees and was sponsored by more than 50 organizations representing all of New York's regions and a wide range of issues, ideologies, resources, approaches, experiences, and populations. Its theme was Connecting Regions, Issues, and Strategies, and its motto was "We are each others' best resources."

The conference had two purposes: (1) to bring together all these diverse organizations and individuals so they could share information, ideas, and energy and go back home strengthened to do their separate work; (2) to explore ways we could combine our strengths and work together to change New York's criminal justice system. The first was accomplished with great success, according to the overwhelmingly positive evaluations of those in attendance. The second has begun to be realized since the conference, as we build a network of activists, advocates, and organizations and put our collective strength into practice on the ground in challenging and changing New York's criminal justice system.

Ensuring the participation of people in prison was a priority for the conference organizers, and has continued to be a priority in building the Network. Through their letters, incarcerated people have contributed their ideas and input. Quotes were chosen from letters and made into posters on the walls of the conference hall so all those in attendance would remember the nearly 90,000 people who are incarcerated in the prisons and jails of New York State. Other quotes from prison letters are included in the Network's brochure and are posted at regional Network meetings. There is an ongoing commitment to include incarcerated people in all the activities of the Network. They are at the center of this work.

The goal of the NYS Prisoner Justice Network is to build a lasting statewide nexus of organizations, activists, incarcerated people, prison families, and communities to challenge the injustices of New York's criminal justice system. Multiple communication tools have been created to connect all the different participants: listserv, web site, postal mailing database (for those in prison and anyone without online access), Facebook page and Twitter.

Throughout 2010 and 2011, the Network grew through local and regional meetings where participants explored problems and solutions in working together and in confronting the power of the criminal justice system. The New York State Legislative Awareness Day for Prisoner Justice: More Justice, Less Prisons, in Albany on May 3, 2011 was one result of the year of regional meetings and statewide phone calls. Its key issues – parole reform, eliminating abusive use of isolation in Special Housing Units, and closing prisons – reflect priorities of member organizations, incarcerated people, and activists.

This directory is an important part of the Network's ability to move forward to change and challenge the injustices of the prison system. Please use it, share it, and make it a stepping stone to further participation in collective action for change and justice.

Let's work together to bring the light of justice and truth to bear on the wrongs of New York's Criminal (In)justice System.

Long before that, in 1975, the League called for improvements in pretrial procedures to assure the rights of defendants at every stage of a criminal proceeding, including the pre-arraignment period. The State League agreed to oppose the death penalty in New York State in 2005. And in 1998 the League began working with the New York State Defenders to improve legal representation for eligible individuals in the courts of New York State.

There is a need for earlier, more effective intervention and, if applicable, treatment. Sanctions should be more innovative, constructive and less restrictive." Long before that, in 1975, the League

called for improvements in pretrial procedures to assure the rights of defendants at every stage of a criminal proceeding, including the pre-arraignment period. In 1998, the League began working with the New York State Defenders to improve legal representation for eligible individuals in the courts of New York State. And in 2005, the State League agreed to oppose the death penalty in New York State.
